#### a | Chapel View

This matter is now with Stratford District Council Enforcement to get some action. Planning Tracker needs to be updated to decipher where we are with all matters

#### b Oldbutt Green/Crest Nicholson

Path area and bank next to the play area has now been seeded by Crest Nicholson.

Discussion took place as to where the SUDS plan is, after completion of the final house, they have sent out a drainage plan, but have not carried the works out. Suggested passing on to Stratford District Council Enforcement to get some action.

Planning Tracker to be updated

Discussion took place on placing dog waste bins on the Oldbutt Green Area, it was reported that this issue is being taken to the next General Purposes Working Group meeting for Discussion

It was also mentioned that the residents are having a battle with the management company to get bins emptied and maintain the land.

Residents have attended a meeting to organise setting up a residents association, this hasn't happened yet.

#### c Herdwick Gate/Herdwick Fold

Works have started on this area now, but pathway is yet to be started.

It was reported that the resident that came to the Annual Town Meeting to ask advice about the management companies not carrying out works that need to be done has now formed a residents forum and is beginning to get results from this.

#### d Drainage issues

Darlingscote road seems to be ok now. Hay Meadow – the high school are trying to sort, but it is not currently leaking.

It was mentioned that Cllr I Cooper has been getting results with regards to the leak from the High School via emails. Cllr J Dinnie requested that Debbie Hardiman, as clerk to the planning committee, contact Cllr Cooper to get copies of these emails, to keep track of what is being done.

Highways have still not cleared drains outside the Chapel View development.

#### e | Electric Vehicle Charging

Contact has been made to Cllr Matecki with regards to Electric Vehicle Charging, no response as of yet

#### f S106 Update

Money has been paid from Stratford District Council. Spreadsheets have been set up ready, a discussion took place with regards to working with the Finance Working Group to spend the money. Spreadsheets have been sent to Cllr I Cooper. It needs to be decided what we have already spent on previous projects and work out how much is left to spend.

Cllr Dinnie reported that he needs to follow up on works they carried out at the latest meeting. They have not heard back from this and will chase it up.

#### i Ellen Badger Update

Discussion took place over different planning applications and how one application has been "finally disposed of" The only application that is currently approved is 21/00004/FUL, to build the whole hospital in 2 phases.

Public meeting to take place on the 18<sup>th</sup> June, with a view to get local residents of Shipston and surrounding villages to take on the task. Josh Dickins, the Mayor or Bishops Castle who has given his help to set all of this up will be attending and will be bringing his chair of committee.
