High Sheriff of Warwickshire presents awards for public service

Joe Greenwell, the High Sheriff of Warwickshire presented three High Sheriff awards to Shipston residents during the Town Council meeting on 8th March. This included a posthumous award to Dr Sue Pritchard, which was accepted on her behalf by her husband Michael Booth, who expressed his gratitude for the outpouring of prayers and love from members of the community following the passing of his wife.

Sue Pritchard

Shortly before Sue passed away, she was recognised with a Fellowship of the Royal College of GPs. She was nominated for a Fellowship for her care and advocacy of the most disadvantaged patients; her ability and knowledge of the networks of statutory and voluntary sectors which enabled her to resolve or improve some of the most intractable problems. She also led a community initiative - DASH (Drugs Action

Shipston); she was the lead clinician in setting up Dementia care in the practice, including the community Dementia cafe, to support Dementia sufferers and their carers. The nomination also referenced her involvement and commitment to teaching; for supporting and developing staff members at the medical centre, as well as caring for them in a pastoral sense.

More recently, Sue had been instrumental in setting up Walking for Health – a fore-runner of the health walks that exist around the county today. Sue was passionate about encouraging movement, exercise and mindfulness and was instrumental in creating Activ08 which also occurred in 2011, to promote the various sports clubs and societies in the town and the importance of exercise in retaining our wellbeing.

About the High Sheriff

The High Sheriff is the Queen's representative in the County for all matters relating to the Judiciary and the maintenance of law and order; much of the High Sheriff's year is therefore spent supporting and encouraging the voluntary and statutory organisations who work in this area. In Warwickshire, this means involvement with the Crown and Magistrates' Courts, in addition to the Police, Prison and Probation Services.

Traditionally, High Sheriffs look after visiting High Court Judges to the county, although such visits are now rare in Warwickshire. However, the High Sheriff does make awards to those who, in the opinion of the Judges at a criminal trial, have been active in the apprehension of certain offenders.

The Office of High Sheriff is apolitical and as such the High Sheriff is in a unique position to be able to bring people together

within the county and to support the enormous contribution made by the emergency services, the armed forces, local authorities, church and faith groups and the voluntary community.

As part of their ceremonial duties, the High Sheriff assists the Lord Lieutenant of the County with Royal visits, is the Official Returning Officer for parliamentary elections and has responsibility for proclaiming the accession of a new Sovereign.

Linda Cornock

Linda Cornock received the Award in recognition of her contribution to the community of Shipston on Stour, using her knitting and needlework skills having set up the Shipston Knitting and Crochet Guild. Over many years, she has knitted beautiful Christmas scenes for the Rotary Victorian Christmas evening. She has knitted sheep to embellish the annual Shipston Wool Fair, 'yarn bombing' the town with countless other objects to enliven Shipston events. She has knitted 100's of poppies to decorate St Edmund's internally and externally in the dramatic waterfall of poppies that cascades from the tower for Remembrance Sunday.

Most recently, Linda has dedicated her time to making masks for the community during the pandemic. She has raised the phenomenal sum of £2000, shared between Shipston First Responders and Shipston Home Nursing.

Charlotte Haines

Charlotte Haines sprang into action, joining the newly created Facebook group, Shipston on Stour Isolation Support Group. This was swiftly renamed Shipston SOS so that the group could continue to offer their support to the community after the pandemic. Possessing outstanding organisational skills, honed by her time serving on and then chairing the Shipston Proms committee, she met with the Town Clerk, the Town Mayor and others to formulate a cohesive plan for the initial logistics and set-up. She became the hub of the group and devised a zone system to ensure that every household was covered. This initiative covered the whole of Shipston and was extended to the villages of Honington, Tidmington, Burmington, Darlingscote and Blackwell. The zone system was used to coordinate the volunteers so that offers of help could be specifically targeted to those in need. She also forged links with the Self Isolation Groups in Brailes, Long Compton, Halford and Tredington. In addition, Charlotte liaises with local social housing providers, Age UK and the local hospitals and food bank.

Search for local health champions

The Stour Health and Wellbeing Partnership is seeking to recruit and develop approximately 16 local health champions. They will be tasked with raising awareness, directing people to local health services and providing help to those who need a little extra support.

These volunteers will be positive role models, supporting people to make positive choices regarding their own health and wellbeing. They will work as part of a team to support people from a wide range of backgrounds. All volunteers will receive access to training and a level 2 qualification from the Royal Society for Public Health.

The training and DBS completion is free of charge, but a commitment of 3 to 4 hours per week is required for a minimum time frame of 6 months. Volunteers will be supported by the organisation, Volunteering Matters, for the first year.

News from Shipston Town Council's March meeting

Local Government Reorganisation District Council Car Park Consultation: District Councillor Trevor Harvey informed the meeting that a car parking consultation was taking place which proposed reducing the waiting time in the Shipston Leisure Centre Car Park from three to two hours. This is the only car park in Shipston potentially impacted and the move is intended to emphasise the car park's purpose is for leisure centre users, not general visitors to the town.

Shipston Area Flood Action Group (SAFAG): Councillors were briefed on SAFAGs plans until summer, which include a mix of natural flood management measures (eg. dams, ponds etc), monitoring projects and Whole Farm Appraisals. 800 interventions will have been completed by the end of the year, covering 36 watercourses, across a 187 sq km area. The proposed budget was accepted in principle by the Town Council subject to the setting up of the new working group

Ellen Badger Hospital: There are growing concerns over the future of the hospital, following conflicting information from interested parties. Councillors welcomed an opportunity to invite the South Warwickshire Foundation Trust's planning consultants to a meeting to brief the Town Council.

Tree complaints and policy: Councillors approved a quote for tree maintenance in Marshall Avenue, Oldbutt Road and Husbandman's Close. The General Purposes Working Group will consider whether to create a policy defining

when action will be taken to address complaints about trees that the council has responsibility for maintaining.

Railway Crescent Cherry Trees: Further information will be sought about the proposed species of tree and what is covered by the two-year maintenance plan. Councillors will discuss the matter further at the next meeting.

Skate Park Lease: The Town Council approved the renewal of the skate park lease (£350 legal costs plus £1 rent a year if requested) subject to consideration of the lease terms by the Finance Working Group.

Band Hall Works: Permission was granted for the Town Band to undertake ventilation works to their building which sits within the Town Council carpark

Ridgeway: Consideration is being given to how the land will be managed as public open space, including the possibility of a new Community Interest Company.

Shipston Probus

Shipston Probus members enjoyed a wideranging talk on the history of the Aston Martin car company given by company historian Steve Waddingham on 26th February. Steve's theme was the continuous linking to the past throughout



its 107-year history. Founded by Robert Bamford and Lionel Martin, the company went through a succession of owners, notably David Brown. Under Brown the company thrived, producing the famous DB models and achieving fame through success at Le Mans and by featuring in James Bond films - you can still buy a DB5 Bond car if you have a spare £3million (even then it is only for show)! Throughout the development of the various models, the distinctive Aston Martin heritage, often in fine detail, continues; for example, in the Bond car, the distinctive red trim of the glove box was continued in later versions.

Currently, twenty percent ownership by Mercedes gives access to a wealth of technology whilst preserving the individuality of the company. What of the future? In a rapidly changing market, Aston Martin hopes to develop a range of new engines, hybrids, fully electric versions and also continue with some petrol units for use on tracks. With 75% of output going for export the prospects look good, despite the current challenges presented by the pandemic and Brexit.

Students in all year groups are now enjoying being back in school classrooms after a period of remote learning. When the move to remote learning began in January, schools had to react quickly. I am very proud of the response from everyone at Shipston High School. Staff in all roles, students and families have all worked very hard to make remote learning a success. The school's work has been appreciated by students and families and colleagues very much value the many kind and supportive comments we have received.

Shipston High School's work on remote learning has also been recognised by the county council, who invited the school to address an audience of council staff and other schools outline OUR



successful approach. It is a credit to everyone at the school that our reputation continues to grow through such recognition.

Proud as we are of our remote learning activities, the best place for young people to learn is in school. Since students returned to the site in March, we have all enjoyed the energy and sense of life that comes with a school full of motivated learners. Many families with children currently in Year 6 will have recently had their places at Shipston High School confirmed for September 2021. 

Shipston Primary School

A year ago, Coronavirus was the still-obscure name of a virus permanently behind, or unable to lead a productive life. With the right approach and a genuine balance of head, heart and hand, these children will be the "bounce back generation". We will be celebrating their ingenuity in the face of multiple challenges, the new things they have learned about themselves and the new knowledge and skills they have acquired.

we had only recently started to hear about, as it stalked its way across Asia and into Europe. Social distancing was unheard of. Lockdowns were things that happened in prisons. Zoom was an ice lolly. It was Friday 13th March 2020 that I first wrote to parents about COVID-19 and a week later when schools across the country 'closed' before reopening for children of key workers and vulnerable children.

Monday 8th March 2021 was a momentous week, when ALL children returned to school full time. During lockdown 3, schools in The Stour Federation Partnership had between 1/4 and 1/3 of children learning in class with their teacher and teaching assistant, whilst the rest of the class learnt remotely with video lessons and assemblies, live Google Meets and regular communication on Seesaw. Schools are in the magicweaving business and it took a tremendous effort from our staff to weave a special kind of magic to keep learning going, with the vast majority of children submitting work regularly. Parents have been wonderful in their support for their children, teachers and the school, but it shows what powerful impact teachers and school life have on children and how learning can make a profound difference in their lives.

After reading more government guidance and writing more risk assessments, like the Blue Peter tortoise, the nation has begun the process of being lifted out of its cardboard box of enforced hibernation. And it was right to begin with our children. There was a real buzz of excitement on the return to school from lockdown. To see the joy on children's faces as they reconnected with friends has been so moving and hopeful. Let's hope it is the beginning of the end of the start-stop education of the last 12 months.

While I hope for no further bubbles popping and no further lockdowns, we will certainly continue to leverage digital teaching and learning effectively in the future, such as parents' evenings, curriculum briefings and meet the new teacher information continuing to be virtual; having an artist in virtual residence for our Arts and Book Week; and collaborating with classrooms down the road and around the world! This will be a blended approach so that in time we can re-introduce our six regular parent sharing afternoons and invite visitors into school to work with classes.

All professional learning for staff since March 2020 has been virtual and we have certainly leveraged digital by accessing training sessions across the country which we wouldn't usually be able to travel to. On a recent Wednesday evening at 10pm I participated in a global webinar with educators from Australia, New Zealand, Taiwan, Hong Kong, The Netherlands, America and Canada! We can build back better, learn from the lockdown experience and improve some of the practices in our schools. To do this we need to be deliberate about how we go about this, sifting the evidence and talking to stakeholders.

Once again, the children have settled back into school life brilliantly - it's like they've never away! I believe it's been such a smooth transition because staff and families worked so hard virtually, which ensured learning continued. Therefore, the children have slotted back into school and we've hit the ground running.

We do need to push back against the unhelpful narrative of the 'lost generation'. This is not a lost generation - they've missed some learning but this has not rendered them incapable,

District Council update

The most important decision that the District Council has taken since last I wrote in February's issue, by far, has been that the proposed amalgamation of Stratford and Warwick District Councils to form a new South Warwickshire Council should proceed to the next stage.

The District Council has been working more closely with Warwick District Council for the past year. For example, tenders from contractors have been sought in recent months on a joint basis, work has started on the development of a single local plan that will cover both Stratford and Warwick Districts' areas and five of the seven Stratford Heads of Service now have responsibility for their areas of operations across both districts. The common theme amongst these developments is that they will each lead to lower costs than otherwise would have been the case.

Stratford's councillors approved the decision to proceed by 34 votes to one, whilst Warwick's councillors gave their approval by 37 votes to nil, with five councillors abstaining. Such a clear decision was only possible because councillors from every single political party represented on either council supported the proposal. Officers will now prepare a submission that can be presented to the Government that will seek approval for a merger by 2024. This proposal will be considered by both Councils no later than July 2021.

Between now and July, there will be a need to consult with various groups across both districts, to assess the degree of support the proposal enjoys. Those who will need to be consulted are obviously the residents of the districts, local businesses as well as other authorities, local bodies and both our local MPs. Crucially, the Government will also assess such a proposal on, amongst other things, the evidence available of the level of local support the proposal commands. I am sure all Shipston's residents recognize the importance of the prospect of this change. I am keen to hear from any of you with your views and to answer any questions you may have. Please feel free to email me.

On a completely different tack, I can report that the response to the £35 early-bird offer in connection with the introduction of the Garden Waste Scheme on 1st April proved even more popular than had been anticipated. When the offer closed on 26 February, 28,656 permits had been issued. I anticipate that, as we enter the grass cutting season, even more residents will opt to join the Scheme.

County Council update

Election Update

Thursday 6th May is local election day. If contested, registered voters in Shipston will have the opportunity to vote for a Councillor to represent them on Warwickshire County Council and join with others across the county to vote for a Police and Crime Commissioner.

Applications to vote can be made online (https://gov.uk/register-to-vote). If you have already registered to vote you do not need to do this again.

In addition to voting in person at their designated polling station, voters can apply for a postal or proxy vote.

Anyone who tests positive for Covid-19 and is required to self-isolate will still be able to participate. They can appoint a proxy (someone to vote on their behalf) up until 5pm on polling day through a modified emergency proxy voting procedure.

Key Deadlines

Shipston Medical Centre

Shipston Medical Centre continues to work with South Warwickshire NHS Trust on the plans to redevelop the Ellen Badger Hospital;

- · Our planning application for the complete development was submitted in December 2020, and we continue to work with the planners.
- · The project team are working with specialist teams including Infection Prevention, Security, Estates and Hotel Services, to develop plans for how the new development will meet varying needs.
- · Work is ongoing with the teams at Ellen Badger and community staff to identify temporary arrangements to ensure services continue throughout

the construction period. This will include the continued provision of the South Warwickshire inpatient beds temporarily relocated to Leamington Hospital.

• The public survey undertaken by Healthwatch is now closed and there was a fantastic response with 550 surveys completed. More information is included on this within the update.

As we are sure you can appreciate COVID-19 has changed healthcare in most aspects, including the way that we care for inpatients. It has also highlighted that all of our areas need to be flexible and adaptable to changing needs.

There are also a number of projects happening outside of this development that will impact future plans, these include a review of urgent care across Warwickshire, Shipston Medical Centre



a national review of diagnostics and a Warwickshire wide review of all discharge to assess beds which includes all of our community beds at the Ellen Badger and the Nicol Unit at Stratford Hospital.

Learning from Covid, as well as the recommendations from these additional projects will inform the next steps. Whilst we don't know yet what will come out of these reviews, we have planned this development in such a way that it is flexible to future requirements.


